Description: This program is designed to provide an understanding of Management's role for implementation of the Quality Management System baseline requirements of the ISO Series Standards; which provides the basis for many other standards and regulations. The scope of the training will include a review of quality management systems (QMS) concepts with specific focus on management leadership, management's role and accountability, context of the organization, responsibility of the process owners, business operations performance effectiveness, metrics and improvement; how the standard provides value added tools for bottom line results, and risk management. Additional discussions include the Registrar's point of view and implementation of management strategies. The course is conducted by a practicing Registrar Lead Auditor and Business Manager, providing first-hand information; the Registrar's expectations as to what must be in place from a management perspective; how best to prepare for certification, certification upgrade, or to maintain certification status. Course format is lecture and discussion.
